

GDPR Privacy Policy

You may have heard about the new General Data Protection Regulation ("GDPR"), that comes into effect May 25, 2018. This privacy policy sets out how the Camberley All Night Café and Lali Guras uses and protects any information that you give Big Fish 117 Ministries. Our primary goal is to make sure that your information is kept confidential at all times.

Big Fish 117 Ministries is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using our service; you can be assured that it will only be used in accordance with this privacy statement.

The processing of personal data, such as the name, address, e-mail address, or telephone number of a data subject shall always be in line with the General Data Protection Regulation (GDPR), and in accordance with the country-specific data protection regulations applicable to the Camberley All Night Café, and the Lali Guras program, namely England and the wider UK.

What we collect

We may collect the following information:

- Name, address and any other contact information including email address
- Demographic information such as postcode and date of birth
- Other information relevant to any online applications, or face to face applications
- We run 24hr CCTV on all areas of the site that are appropriate, we reserve the right to use this in the event that any allegations or suspicions of illegal activity occur and this can be given to the authorities to aid in their investigation.

What we do with the information we gather

We require this information to understand your needs and provide you with a better service, for the following reasons:

- Internal record keeping
- Face to face and online Applications
- We may require to contact you by email or phone

Our responsibility

We vow to follow the strict rules of the "data protection principles" to make sure any information collected is:

- Used fairly, lawfully & transparently
- Used for explicit, specified purpose
- Used only in a way that is relevant and necessary
- Kept up to date and accurate
- Kept for no longer than necessary
- Kept secure

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

We will not sell, distribute or lease your personal information to third parties unless we have your written permission or are required by law to do so.
